This is a summary of the annual report for the MIDDLETOWN WORKS HOURLY & SALARIED UNION RETIREES HEALTH CARE FUND, (Employer Identification No. 36-7485085, Plan No. 501) for plan year ending December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan had contracts with Humana Insurance Company and Metropolitan Life Insurance to provide prescription and life insurance benefits. The total premiums paid for the plan year ending December 31, 2022 were \$10,355,486.

Basic Financial Statements

The value of plan assets, after subtracting liabilities of the plan, was \$595,759,687 as of December 31, 2022 compared to \$734,647,113 as of January 1, 2022. During the plan year the plan experienced a decrease in its assets of \$138,887,426. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$(100,409,010). This income included employee contributions of \$2,802,402, realized losses of \$4,056,563 from the sale of assets, earnings from investments of \$(99,545,364) and other income of \$390,515. Plan expenses were \$38,478,416. These expenses included \$1,744,658 in administrative expenses and \$36,733,758 in benefits paid to participants and beneficiaries.
